  - 2. The trustee faithfully and properly fulfilled the duties enumerated in 11 U.S.C. §704.
- 3. All scheduled and known assets of the estate have been reduced to cash, released to the debtor as exempt property pursuant to 11 U.S.C. § 522, or have been or will be abandoned pursuant to 11 U.S.C. § 554. An individual estate property record and report showing the disposition of all property of the estate is attached as **Exhibit A.** 
  - 4. The trustee realized the gross receipts of \$ 913,113.81 Funds were disbursed in the following amounts:

The Trustee's Final Report is expected to be filed with the Office of the Assistant U.S. Trustee by July 12, 2019. Barring any objection to this application and the Final Report, the case should be completed by September 30, 2019 and funds distributed by October 7, 2019. All services included therein were provided by counsel and his office staff.
