DEBTOR'S CERTIFICATION TO THE COURT REGARDING ENTRY OF CHAPTER 13 DISCHARGE

(This amount was subject to adjustment on 4/1/2025 and is adjusted every 3 years thereafter with respect to cases commenced on or after the date of the adjustment.) in the aggregate that the Debtor or a dependent uses as a residence, claimed as a homestead, or acquired as a burial plot as specified in 11 U.S.C. \$522(q)(1). If the Debtor has claimed such an exemption under State or local law in excess of the applicable amount under \$522(q)(1), then no reasonable cause exists to believe that 11 U.S.C. \$522(q)(1) may be applicable to the Debtor and there is not a pending proceeding in which the Debtor may be found guilty of a felony of the kind described in 11 U.S.C. \$522(q)(1)(B).
