GENERAL ORDER 20-3

In General Order 20-2, considering the state of emergency declared by the State of West Virginia in response to the COVID-19 coronavirus, and considering the Regional Office of the United States Trustee Program's intention to continue meetings of creditors set under Federal Rule of Bankruptcy Procedure 2003(a) in favor of conducting such examinations by alternative means, the Court entered General Order 20-2, whereby it extended certain deadlines related to the date first set for the meeting of creditors.

More specifically, in General Order 20-2, the Court Ordered on March 18, 2020, that the following deadlines were extended in all cases then pending, and in all future cases filed in this District, until such time as this General Order is rescinded.

1. The deadline set under Federal Rule of Bankruptcy Procedure 1017(e) for the United States Trustee to file a motion to dismiss for abuse is hereby EXTENDED to 60 days from the completion of the meeting of creditors.
2. The deadline set under Federal Rule of Bankruptcy Procedure 4004(a) for a party in interest to object to entry of discharge be and hereby is EXTENDED to 60 days from the completion of the meeting of creditors.
3. The deadline set under Federal Rule of Bankruptcy Procedure 4007(c) for a party in interest to file a complaint to obtain a determination of the dischargeability of any debt, be and hereby is EXTENDED to 60 days from the completion of the meeting of creditors.

On March 23, 2020, the Office of the United States Trustee provided the Bankruptcy Clerk's Office new instructions for setting meetings of creditors by telephonic means in lieu of setting those hearings in person, at a physical location. Therefore, it is:

ORDERED that General Order 20-2 be and hereby is RESCINDED and General Order 20-2 shall be of no further force or effect, except in the following cases:
